- 1.3. Develop an operational guideline/information document/protocol to help the IIM Raipur community explore state-of-the-art case methods and case writing, which must be updated periodically.
- 1.4. Develop a website to showcase the activities of the Case Centre.
- 1.5. Create and manage the social media handles (if applicable) LinkedIn, Twitter, and relevant social media platforms.
- 1.6. Enhance network with various Indian and foreign stakeholders, including academicians, industry leaders, bureaucrats, and case selling platforms, and endeavour mutually beneficial partnerships with them.
- 1.7. Develop working papers on case methods in business management and policy education in the Indian context.
- 1.8. Support developing credit courses on case methods, case writing workshops, case analysis, and relevant activities to case-based pedagogy in management education.
